Doing business conducted while in session, Commissioner Gary Scherer offered the motion, seconded by Commissioner Harold Henson, to adopt the Resolution:

WHEREAS, Ohio Revised Code Chapter 715 (the “Act”) empowers certain political subdivisions to form joint economic development districts to share in the costs of improvements for economic development purposes; and,

WHEREAS, Pursuant to the Act, and Resolution No. 09-01, passed on December 29, 2009 by the Board of Township Trustees of Madison Township (the “Township”), Ordinance No. 2007-04, passed on May 21, 2007 by the Village Council of the Village of Ashville, Pickaway County, Ohio (the “Village”), and Ordinance No. 1787-2008, passed on February 9, 2009 by the City Council of the City of Columbus, Ohio (the “City”), the Township, the Village, and the City are each party to the Madison Township Joint Economic Development District Contract dated June 30, 2010, as amended from time to time (the “Original JEDD Contract”), which such Original JEDD Contract creates and provides for the operation of a joint economic development district known as the Madison Township Joint Economic Development District (the “District”); and,

WHEREAS, The City, Township, and the Village executed an amendment to the Original JEDD Contract to support the development of a parcel of land within the Township by DRCS, LLC (the “DRCS Amendment”); and,

WHEREAS, On August 20, 2019, the City, Township and the Village executed the Amended and Restated Madison Township Joint Economic Development District Contract to support development of a parcel of land within the Township (the “Amended and Restated JEDD Contract”); and,

WHEREAS, The City, Township, and the Village executed a further amendment to the Original JEDD Contract to support development of a parcel of land within the Township by Scarbrough Farms FLP and CT Realty Group, LLC and its affiliates as future successor owners (the “CT Amendment” and, together with the DRCS Amendment and the Amended and Restated JEDD Contract, the “Prior Amendments” constituting, collectively with the Original JEDD Contract, the “JEDD Contract”); and,

WHEREAS, Pursuant to Ohio Revised Section 715.72(L), the Village, the Township, and the City now desire to amend the JEDD Contract to add certain additional real property as further described in Exhibit A (the “2025 Additional Property”) to the territory of the District and, to that end, have negotiated an Amendment to the JEDD Contract, a form of which is attached hereto as Exhibit B (the “2025 Expansion Amendment”); and,

WHEREAS, Pursuant to Ohio Revised Code Section 715.72, the Township, the Village, and the City each conducted, or intend to conduct, a public hearing regarding the addition of the 2025 Additional Property and the approval of the 2025 Expansion Amendment with appropriate public notice, and made available for public examination all documents required by the Act for review; and,

WHEREAS, To encourage economic development within the Village, the Township, and the City, the parties have further negotiated a Second Amended and Restated Madison Township Joint Economic Development District Contract (the “Second Amended and Restated JEDD Contract”), a form of which is attached as Exhibit K to the 2025 Expansion Amendment; and,

WHEREAS, To conform to changes authorized pursuant to the 2025 Expansion Amendment and the Second Amended and Restated JEDD Contract, the Village, the Township, and the City further desire to amend the Madison Township Annexation Moratorium Agreement (the “Original AMA”) effective June 30,

2010, as amended by prior amendments to the Original AMA, to confirm that the 2025 Additional Property is included in the area included within the Original AMA and to extend the term of the Original AMA, and to that end, have negotiated an amendment to the Original AMA (the “2025 AMA Amendment”), a form of which is attached hereto as Exhibit C; and,

WHEREAS, this Board of County Commissioners of Pickaway County, Ohio (the “Board”) has been provided with copies of the 2025 Expansion Amendment, the Second Amended and Restated JEDD Contract, and the 2025 AMA Amendment and desires to provide its approval to support the City, the Township, and the Village, all pursuant to the terms of the Act and the JEDD Contract.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Pickaway County, Ohio, that:

SECTION 1. This Board finds that the requirements of Section 5 of the JEDD Contract, including that appropriate zoning is, or will be, in place, and Ohio Revised Code Section 715.72, have, or will be, met and this Board approves the 2025 Expansion Amendment in substantially the form attached to this Resolution as Exhibit B. Notwithstanding anything to the contrary, each portion of the 2025 Additional Property shall only be added to the territory of the District pursuant to the 2025 Expansion Amendment upon receipt by the District of written confirmation that no electors reside upon the 2025 Additional Property, as applicable.

SECTION 2. Pursuant to its approval of the 2025 Expansion Amendment, this Board further approves the Second Amended and Restated JEDD Contract attached in substantially the form as Exhibit K to the 2025 Expansion Amendment.

SECTION 3. This Board approves the 2025 AMA Amendment in substantially the form attached to this Resolution as Exhibit C.

SECTION 4. The Clerk of this Board shall retain on file a copy of the 2025 Expansion Amendment, the Second Amended and Restated JEDD Contract, and the 2025 AMA Amendment, together with all applicable exhibits attached thereto, including (i) the depictions and identification of the parcels constituting the 2025 Additional Property and (ii) Ohio Revised Code Section 715.72 as effective on the date of this Resolution.

SECTION 5. This Board hereby finds and determines that all formal actions of this Board concerning and relating to the adoption of this Resolution were taken in an open meeting of this Board and that all deliberations of this Board and of any of its committees that resulted in those formal actions occurred in meetings open to the public, in compliance with law, including Ohio Revised Code Section 121.22.

SECTION 6. This Resolution shall take effect and be in full force immediately upon its passage and approval and shall be effective at the earliest date allowed by law.
