In the Matter of County Infrastructure Discussion:

Ryan Scribner and David Glass, P3, met with the Commissioners to provide an update regarding growth in Pickaway County. Mr. Scribner and Mr. Glass have spoken with townships and villages regarding the growth and there seems to be some frustrations. The parties feel that a meeting would be a good idea. Commercial Point scored the lowest for funding from the County and they are one with the most growth right now. Mr. Scribner is meeting with ODOT and the developers today. An upcoming Transportation Improvement District meeting will be arranged.

In the Matter of Courthouse Chimes:

Tom Duvall met with the Commissioners to discuss the schedule of the chimes playing. In the past the chimes would play throughout the day and since his family has moved back to the area, he does not hear the chimes playing like in the past. He was concerned that there is a reason for that or if the locals did not like hearing them. Commissioner Wippel informed Mr. Duvall that Don Metzler used to play the chimes and there has been some changes. There is a group called Foreschimes Group that oversee the chimes. Mr. Duvall asked if he could touch base with Ellery Elick to come up with a plan and have Ellery schedule with the Commissioners to discuss the plan with guidelines.

Mr. Duvall attended his first Township meeting regarding the rezoning of Circleville Township. The request was to re-zone to residential zone, which will make it for low-income and senior housing. The property is currently zoned for industrial, and money has been raised for industrial. The Commissioners sent a letter expressing that it is not in the best interest of the city to change to residential.

In the Matter of Ross, Pickaway, Highland, Fayette County Solid Waste:

Erica Tucker, RPHF Solid Waste Director, met with the Commissioners to informed them that Rumpke has reached out to her regarding that they are wanting to sell the building and five aces located on State Route 22 West. This would allow for one large site and no longer have satellite facilities in Pickaway County. Commissioner Wippel asked how would operate it and Mrs. Tucker explained that it would be RPHF Solid Waste. It would be fenced in with key phone access. She would like to open to additional types of recycling such as clothing, tires, etc. It can be written into the 2022 plan to have a part time employee hired to run the site. Commissioner Wippel asked what the cost savings would be if combined into one site and Mrs. Tucker explained that they are not charged where the dumpsters are located but are charged for the dumpster rental. They must pay Rumpke each time the dumpsters are picked up.

Commissioner Wippel asked how Rumpke came up with the number \$499,000 for the site and Mrs. Tucker went on that it was a number mentioned and she would like to get a letter of intent before it is listed to the public. Now in Fayette County it is by appointment only because of the space and no office on site. Rs. Tuckers thoughts were that the front building could become the office for RPHF Solid Waste. There is a building that the electric company rents and there would be other buildings that could be leased to other County Offices such as Park District. Commissioners informed that the Park District will have their own office in the near future. Commissioner Scherer addressed the cost difference if they purchased bare land and put up a pole barn and fencing if it would be a lower cost. Commissioner Wippel asked who Mrs. Tucker thought would purchase the property and she explained the RPHF Solid Waste District. There is concern that additional employees will be needed and there would have to be agreement from the Board members from the other counties. The Ohio EPA is behind Mrs. Tucker, but Commissioner Wippel has concerns that it is not worth \$499,000. Commissioner Henson suggested that it be inspected prior to a decision. Commissioner Scherer asked how much the key fob system is and Mrs. Tucker stated that Fayette County key fob systems was \$100,000. Why would the district want to own the property versus the county and Mrs. Tucker thought maybe it was the route to go. The storm drainage at the site does back-up and Commissioner Wippel feels that it is a fixer upper, and negotiation of the prices would need to be addressed. Commissioner Henson asked if losing the convenience of satellite sites would make it harder for individuals to drop off recyclables and Mrs. Grooms said that there is no convenience with recycling. Individuals like to come to a clean facility and not have trash and furniture all over the site. They may leave 3-4 satellite sites and have one mega site. Commissioner Henson's thoughts are it is \$499,000 and it would have to do half a million dollars of good for the entire county. That is just the cost to get the property and does not include maintenance and renovations needed. Commissioner Scherer asked if Mrs. Tucker has heard from any of the other counties or board members and she has heard form Highland and waiting to hear from others. Commissioner Wippel asked for Mrs. Tucker to let them know what she gathers from the other counties. Commissioner Scherer suggested to let them list it and that will show the value of the property.
